

# Chuao Chocolatier "Random Acts of Sweetness" Photo Contest 2014

#### OFFICIAL RULES

PHOTO CONTEST IS OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES 18 YEARS OF AGE OR OLDER.

#### **ELIGIBILITY:**

Each Entrant must be a legal resident of the United States or the District of Columbia, 18 years of age or older at time of entry. #### HOW TO ENTER:

The Photo Contest begins at 12 a.m. PST on November 10, 2014 and ends at 11:59 p.m. PST on November 23, 2014 (the "Photo Contest period"). You can find the application on the Random Acts of Sweetness tab on the Chuao Chocolatier Facebook Fan Page. In order to become a fan you must "like" the Chuao Chocolatier page. You will need to provide first and last name, email address, date of birth, zip code and upload a photo of a random act of sweetness, using the hashtag #randomactsofsweetness, via the Photo Contest app on Facebook, or directly onto Twitter or Instagram. All social media accounts must be set to "public" in order to enter Photo Contest via hashtag. All entries must be received by 11:59 p.m. PST on November 23, 2014. Photos using Photo Contest hashtag before 12 a.m. PST on November 10, 2014 are not eligible and will be removed from the sweepstakes. Any other method of entry is void. Noncompliance with any entry procedure will result in disqualification. All Photos submitted must be unique, produced by the Entrant. Photography submitted from the public domain will be disqualified. In the event of a dispute as to the identity of an Entrant, the Entrant will be deemed the name appearing on the Entry. Participants may enter as many photos as they like.

## HOW TO ENTER (CONT.):

By submitting your entry, you agree that you give the Sponsor permission for the use of your name, image and/or likeness and you grant the Sponsor the right to post your entry on www.chuaochocolatier.com and Chuao Chocolatier social sites during and after the Photo Contest. You may be required to submit a release (to be provided by Sponsor) granting Sponsor permission to use your name and/or likeness. Entries that communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate will be disqualified in Sponsor's sole discretion.

## PHOTO REQUIREMENTS:

The photo must capture a random act of sweetness in a JPEG or PGN file no larger than 2MB. Sponsor has the sole discretion to determine whether a Photo qualifies. Any Photo Entry not in compliance with the above will be disqualified. By entering, you understand and agree that your Photo may (in Sponsor's sole discretion) be posted online for consumers to view on https://www.facebook.com/chuaochocolatier or other Sponsor-selected sites and you agree to waive any rights you may have to the Photo submitted. Sponsor will only post select Photos, at their sole discretion. Sponsor reserves the right to remove any posted Photo, in its sole discretion, even if the Photo has already been made available to the public.

## SELECTION OF WINNER:

Winners will be selected at random from all eligible Entries received during the Entry Period. All decisions of the Administrator shall be final and binding. Grand Prize winner will be randomly selected and notified by social media tag and email (if provided) on or about November 24, 2014. One winner will be randomly selected a week for two (2) weeks from November 10, 2014 to November 23, 2014 (the "Photo Contest period"), for a total of two (2) weekly winners. Weekly Winners will be notified on November 14, 2014 and November 21, 2014 by social media tag and email (if provided). One winner per day will be randomly selected for eleven (11) days during the Photo Contest period and notified the same day by social media tag or email (if provided). Winners are eligible for one prize total, so Daily and Weekly Winners are not eligible for Grand Prize. The prizes must be accepted "as is" — no substitution or transfer of a prize is permitted and no cash equivalent will be awarded. Potential winners will be given instructions on how to claim prize. Winners will be required to sign and return an affidavit of eligibility and liability/publicity release within three (3) days of prize notification or prize will be forfeited. If the entrant whose winning entry is chosen does not reply within allotted time, then the prize will be forfeited.
